

#### Guest Preacher, Dr. Lisa Marie Bowens



Lisa Marie Bowens, PhD '14, associate professor of New Testament at Princeton Theological Seminary, earned a BS (cum laude), MSBE, and MLIS from the University of North Carolina at Greensboro, an MTS and ThM from Duke Divinity School, and a PhD from Princeton Theological Seminary. Her first book, *An Apostle in Battle: Paul and Spiritual Warfare in 2 Corinthians 12:1-10* (Mohr Siebeck), is a revision of her dissertation and examines Paul's ascent to the third heaven through a cosmic/apocalyptic lens. It traces martial imagery in the letter and explores how this imagery facilitates understanding Paul's journey as an example of spiritual warfare. Her second book, *African American Readings of Paul:* 

Reception, Resistance, and Transformation (Eerdmans), is the first book to investigate a historical trajectory of how African Americans have understood Paul and utilized his work to resist and protest injustice and racism in their own writings from the 1700s to the mid-twentieth century. Her current projects include working as a contributor and co-editor with Scot McKnight and Joseph Modica on *Preaching Romans From Here* (forthcoming), as co-writer with Amy Peeler on an article on New Testament, race, and gender for *The New Testament in Color* (forthcoming) and two commentaries, one on 2 Corinthians and one on 1-2 Thessalonians.

Her research interests include Paul and apocalyptic literature, Pauline anthropology, Pauline epistemology, discipleship in the gospels, African American Pauline Hermeneutics, and New Testament exegesis and interpretation. She is a member of the Society of Biblical Literature, the Society of Pentecostal Studies, Society for the Study of Black Religion, American Academy of Religion, and a past Fund for Theological Education fellow. She is also a member of the following editorial teams: Bulletin for Biblical Research Journal, Horizons in Biblical Theology, New Testament Studies, and Journal for the Study of Paul and His Letters; and a member of the following Steering Committees: Ethics and Biblical Interpretation (co-chair SBL), African American Biblical Hermeneutics Group (SBL), Pauline Theology Group (SBL), and Forum on Missional Hermeneutics (SBL). She is a recipient of the Wabash Early Career Teaching Fellowship and the Louisville Institute First Book Grant for Scholars of Color. Some of her current courses are Paul and Apocalyptic Thought, Greek Exegesis of 2 Corinthians, African American Pauline Hermeneutics, Introduction to New Testament Greek, and Introduction to New Testament Exegesis.

#### REDRESS OF IMBALANCE

The *Book of Order* (G-3.0301) requires the Presbytery to "adopt and communicate to the sessions a plan for determining how many ruling elders each session should elect as commissioners to Presbytery."

An examination of the total number of members of the congregations of the Presbytery and the total number of minister members reveals a ratio of 77 congregants for every minister member. Using each congregation's reported 2020 membership and assigning 1 ruling elder commissioner for every 77 members would lead to the following number of ruling elder commissioners for each Presbytery meeting. (*Please note: This allocation caps the maximum number of ruling elder commissioners for all congregations of 2,000 or more at 20.*)



#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Nature of Activities**

The Trustees of the Presbytery of Philadelphia (the Presbytery) is a nonprofit corporation which is under the jurisdiction of the General Assembly of the Presbyterian Church (U.S.A.) and regional Synod. The Presbytery has jurisdiction over local churches of the Presbyterian Church (U.S.A.) in Bucks, Delaware, Montgomery, and Philadelphia counties (114 churches at December 31, 2021). In the Presbyterian Church (U.S.A.), each local church is required to form a nonprofit corporation. The Presbyterian Church (U.S.A.) also provides that all property of a Church (or a Presbytery and affiliated entities) is held in trust for the use and benefit of the denomination; upon dissolution of any Church, the assets of the dissolved entity come under the control of and revert to the Presbytery. No church or affiliated organization under Presbytery jurisdiction may borrow money or purchase, sell, lease, or encumber any property without the approval of the Presbytery.

#### **Basis of Accounting**

The Presbytery prepares its financial statements on the modified cash basis of accounting. The modified cash basis of accounting is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under this basis of accounting, certain revenues and assets are recognized when received rather than when earned and certain expenses are recognized when paid rather than when the obligations are incurred. Consequently, the Presbytery has not recognized trade receivables, accounts payable to vendors and their related effects on the change in net assets in the accompanying financial statements.

#### **Financial Statement Presentation**

The Presbytery follows the provisions of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 958, *Not-for-Profit Entities*. The standard requires the Presbytery to classify its net assets into two categories: net asset without donor restrictions and net assets with donor restrictions. In addition, the guidance requires enhanced disclosures about governing board designations; composition of net assets with donor restrictions; the Presbytery's liquidity; and expenses by both their natural and functional classification.

The activities of the Presbytery are included in two separate categories of net assets: net assets without donor restrictions and net assets with donor restrictions. Net assets with donor restrictions include amounts restricted in perpetuity by the donor in accordance with the original or amended gift documents. It also includes gifts restricted by donors for specific programs and other operating purposes and pledge receipts restricted for the Presbytery's upcoming year. When such restrictions are satisfied, net assets are then reclassified to net assets without donor restrictions. All other activities of the Presbytery are considered net assets without donor restrictions.

#### **Use of Estimates**

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Cash and Cash Equivalents

The Presbytery considers all highly liquid instruments with an initial maturity of three months or less to be cash equivalents.

#### Contributions

Donor-restricted contributions are reported as increases in net assets with donor restrictions depending on the nature of the restrictions. When a restriction expires (that is when a stipulated time restriction expires or a purpose restriction is accomplished), net assets with donor restrictions are reclassified to net assets without donor restrictions and reported in the statement of revenue, expenses and other changes in net assets as satisfaction of program restriction.

The Presbytery reports gifts of real estate and equipment as support without donor restrictions unless explicit donor stipulations specify how the donated assets must be used. Gifts of long-lived assets with explicit restrictions that specify how the assets are to be used and gifts of cash or other assets that must be used to acquire long-lived assets are to be reported as support with donor restrictions. Absent explicit donor stipulations that define how long those long-lived assets must be maintained, the Presbytery reports expirations of donor restrictions when the donated or acquired long-lived assets are placed in service.

#### Investments

The Presbytery's investments in marketable equity and fixed income securities with readily determinable fair values are valued at their fair values in the statement of assets, liabilities and net assets. Alternative investments are valued by investment managers. Because alternative investments are not readily marketable, their estimated values are subject to uncertainty and therefore may differ from the value that would have been used had a ready market for such investment existed. A partial interest in real estate is held by the Presbytery. This real estate has no readily available market value and is stated at cost. The carrying amount of the cost basis investment was \$100,000 at December 31, 2021. Realized and unrealized gains and losses along with interest and dividends are included in the statement of revenues, expenses, and other changes in net assets.

#### **Investments (Continued)**

Investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in values of the investments will occur in the near-term and that such changes could materially affect the amounts reported in the statement of assets, liabilities and net assets. Realized and unrealized investment gains and losses are determined by comparison of the average cost to proceeds at the time of disposal or market value at the financial statement date. These gains and losses and other investment income are reflected in the statement of revenues, expenses, and other changes in net assets.

#### Loans Receivable

Loans receivable include revolving loans, grant mortgages, community investment, and Good Shepherd loans. Revolving loans represent funds loaned to churches and ministers. These loans are generally repaid in installments ranging from \$39 to \$637 per month, including interest at rates ranging up to 4.5%, with terms ranging from five to fifteen years. On occasion, the Presbytery loans funds to churches with deferred payment terms.

Allowances for doubtful accounts are established based on prior collection experience and current economic factors which, in management's judgment, could influence the ability of loan recipients to repay the amounts per the loan terms. Loan balances are written off only when they are deemed to be permanently uncollectible.

#### Land Lease

Land lease is recorded at cost, net of accumulated amortization. Amortization is computed utilizing the straight-line method over the estimated lease term of 49 years.

#### Property and Equipment

Property and equipment are recorded at cost, except for gifts of physical properties which are recorded at estimated fair value when received.

The Presbytery capitalizes all major purchases of property and equipment. Assets are depreciated over the estimated useful life of the asset using the straight-line method. Building and building components are depreciated over an estimated useful life of 3 to 50 years. Furniture, fixtures, computers, and office equipment are depreciated over estimated useful lives of 3 to 20 years. Management's policy is to capitalize property and equipment acquisitions having a cost of \$5,000 or greater.

Properties that are titled to the Presbytery without paid consideration are valued at the appraised or at the tax assessed value on the date title is given.

The Presbytery has a reversionary interest in all Presbyterian Church (U.S.A.) churches in its four-county jurisdiction. For the year ended December 31, 2021, there were three church reversions to the Presbytery.

#### **Agency Accounts**

Agency accounts represent funds received for organizations, committees and programs for which the Presbytery serves as a conduit and to which the funds have not yet been transmitted.

#### **Amounts Held on Behalf of Churches**

During 2017, the Presbytery received and invested insurance proceeds from one of its churches pending redevelopment as a result of a fire. The balance at December 31, 2021 was \$6,368,451. During 2020, the Presbytery received and invested sales proceeds from one of its churches. The balance at December 31, 2021 was \$154,583. These funds are maintained in a distinct portfolio within the Presbytery's investments and there is a corresponding liability on the statement of assets, liabilities, and net assets to reflect the amounts held on behalf of churches.

#### **Tax-Exempt Status**

As part of the Presbyterian Church (U.S.A.) the Presbytery is a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code (IRC) and under similar provisions of the Pennsylvania tax code.

#### **Concentration of Credit Risk**

Financial instruments that potentially expose the Presbytery to a concentration of credit risk consist primarily of cash and cash equivalents and investments. The Presbytery places its cash and temporary cash investments with financial institutions. At times, such balances may be in excess of the Federal Deposit Insurance Corporation (FDIC) insurance limits. Investments are managed by third-party administrators whose investment recommendations to management are diversified in a way that is consistent with the risk tolerance and investment objectives of the Presbytery's investment policy.

#### **Uniform Prudent Management of Institutional Funds Act**

The Uniform Prudent Management of Institutional Funds Act (UPMIFA) provides guidance on the classification of endowment fund net assets for states that have enacted versions of the UPMIFA, and enhances disclosures for endowment funds. Because UPMIFA has not become law in the Commonwealth of Pennsylvania, possible reclassifications of net assets are not required to be made. Disclosure of prevailing law in the Commonwealth of Pennsylvania and enhanced required disclosures have been included in Note 2.

#### **Fair Value Measurements**

The Presbytery measures fair value using a three-level hierarchy for fair value measurements based upon the transparency of inputs to the valuation of an asset or liability. Inputs may be observable or unobservable and refer broadly to the assumptions that market participants would use in pricing the asset or liability. Observable inputs reflect the assumptions market participants would use in pricing the asset or liability based on market data obtained from sources independent of the reporting entity. Unobservable inputs reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The fair value hierarchy consists of three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs that utilize quoted prices (unadjusted) in active markets for identical assets or liabilities that the Presbytery has the ability to access.

Level 2 – Inputs that include quoted prices for similar assets and liabilities in active markets and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument. Fair values for these instruments are estimated using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows.

Level 3 – Inputs that are unobservable inputs for the asset or liability, which are typically based on an entity's own assumptions, as there is little, if any, related market activity.

The carrying amounts for cash equivalents approximate their fair value because of their short-term maturity.

A financial asset's or liability's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The following valuation techniques were used to measure fair value of financial instruments owned as of December 31, 2021:

Marketable equities and mutual funds – Fair value of equities and mutual funds is based on quoted market prices for the identical security. These investments are included in the fair value hierarchy as Level 1.

Alternative investments – The Presbytery's alternative investments consist of hedge funds and private equity funds. The fair value of alternative investments is based on estimated fair values provided by investment managers. Management reviews and evaluates the values and agrees with the valuation methods and assumptions used in determining the fair value of the alternative investments.

The Presbytery had unfunded commitments of \$417,600 at December 31, 2021.

Split interest agreements – Fair value of the split interest agreements (Pooled Income Plan) was based on the present value of future cash inflows. These assets are included in the fair value hierarchy as Level 3.

#### Comparative Information

The financial statements include certain prior-year summarized comparative information in total but not by net asset class. Such information does not include sufficient detail to constitute a presentation in conformity with the modified cash basis of accounting. Accordingly, such information should be read in conjunction with the Presbytery's financial statements for the year ended December 31 of the prior year, from which the summarized information was derived.

#### Reclassifications

Certain prior year amounts were reclassified to conform to the current year presentation.

#### **Subsequent Events**

In preparing these financial statements, the Presbytery has evaluated events and transactions for potential disclosure through October 13, 2022, the date the financial statements were available to be issued.

The Presbytery's endowments consist of individual funds established for a variety of purposes. Its endowments consist of board-designated and donor-restricted endowments. Net assets associated with endowment funds are classified and reported based on the existence or absence of donor-imposed restrictions.

The board of trustees of the Presbytery has interpreted the relevant state law as requiring the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment funds absent explicit donor stipulations to the contrary. As a result of this interpretation, the Presbytery classifies as net assets held in perpetuity (a) the original value of gifts donated to the permanent endowment, (b) the original value of subsequent gifts to the permanent endowment, and (c) accumulations to the permanent endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund. The Presbytery allocates income, gains (losses), and expenditures according to fund restrictions. Unless specifically defined, for a donor-restricted endowment fund that is required by donor stipulation to accumulate or appropriate endowment funds, the Presbytery considers the following factors:

- 1) The duration and preservation of the fund
- 2) The purposes of the Presbytery and the donor-restricted endowment fund
- 3) General economic conditions
- 4) The possible effect of inflation and deflation
- 5) The expected total return from income and appreciation of investments
- 6) Other resources of the Presbytery
- 7) The investment policies of the Presbytery

The Presbytery has adopted investment and spending policies for endowment assets that attempt to provide a predictable stream of funding to programs supported by its endowments while seeking to maintain the purchasing power of the endowment assets. Endowment assets include those assets of donor-restricted funds that the Presbytery must hold in perpetuity or for a donor-specified period(s) as well as board-designated funds. Under this policy, as approved by the board of trustees, the endowment assets are invested in a manner that is intended to produce a return that approximates the results of the S&P 500 index while assuming a moderate level of investment risk. The Presbytery expects its endowment funds, *over* time, to provide an *average* rate of return of approximately 7% annually. Actual returns in any given year may vary from this amount.

The Presbytery relies on a total return strategy in which investment returns are achieved through both capital appreciation (realized and unrealized) and current yield (interest and dividends). The Presbytery targets a diversified asset allocation that places a greater emphasis on equity-based investments to achieve its long-term return objectives within prudent risk constraints. The Presbytery employs a third party investment advisor to oversee the management of its assets.

The Presbytery has a total return policy of appropriating for distribution each year a percent of its endowment funds' average fair value over the prior three calendar year ends. This percentage was 5% for 2021. If the total return amount exceeds the actual earnings of the endowment funds in any one year, then the amount needed to fund such excess will first be taken from the accumulated excess earnings from prior years, then from the accumulated net capital gains of endowment funds and, conversely, any undistributed income after the allocation of the total return distribution is added back to the endowment fund balance. In establishing this policy, the Presbytery considered the long-term expected return on its endowment. Accordingly, over the long-term, the Presbytery expects the current spending policy to allow its endowment to grow at an average of 2% annually. This is consistent with the Presbytery's objective to maintain the purchasing power of the endowment assets held in perpetuity or for a specified term as well as to provide additional real growth through new gifts and excess investment return.

#### NOTE 4 SPLIT-INTEREST AGREEMENTS

The Presbyterian Church (U.S.A.) Foundation has pooled income plans for members of the Presbyterian Church. Certain members of the Presbyterian Church have contributed gifts to these plans for the benefit of the Presbytery. The Presbyterian Church (U.S.A.) Foundation administers the plans and makes payments to the recipients during their lives. Upon termination of the pooled income plans, the remainder interest will be available to the Presbytery.

Gifts to the pooled income plans are recorded at their present value based on the donor's life expectancy. The assets of the pooled income plans are recorded at their market value. Discounts for future interest are amortized and recorded as changes in value of pooled income plan assets in the statement of revenues, expenses, and other changes in net assets.

The amount available for transfer is limited in order to preserve the principal held in perpetuity.

#### NOTE 7 RETIREMENT PLANS

The Presbytery has two retirement plans. The Presbytery makes contributions to a multiemployer retirement plan administered by the Board of Pensions of the Presbyterian Church (U.S.A.), which is a defined benefit plan. The Presbytery's participation in the defined benefit plan constitutes less than 1% of total plan contributions. The defined benefit plan covers all of the Presbytery's full time ordained ministers. The funded status of the defined benefit plan was 160% at December 31, 2021, the date of the last plan audit. The Board of Pensions of the Presbyterian Church (U.S.A.) is wholly responsible for the ultimate payment of pension and other benefits for participating Presbytery employees. The Presbytery is not obligated for any underfunding of the defined benefit plan, nor can it recover any overfunding. It is only responsible to pay the defined contributions discussed above.

The defined benefit plan covers substantially all qualifying members who serve, or have served, the Presbyterian Church. Under the defined benefit plan eligible participants can begin receiving benefits at:

- Normal retirement at age 65, or
- Early retirement at age 55

During 2021, \$21,273 of dues paid to the Board of Pensions (which also provides medical and other benefits) represented contributions to the defined benefit plan.

The second plan covers certain employees with a minimum of one year of service who are not included in the defined benefit plan. The plan is a defined contribution plan and is administered by Fidelity Investments. The Presbytery contributes a fixed percentage of eligible employees' salaries and all employees eligible to participate in the defined contribution plan may voluntarily contribute to the plan. During 2021, the Presbytery contributed \$4,411 to the defined contribution plan.

#### NOTE 8 OPERATING LEASES

The Presbytery leases certain equipment under the terms of operating leases. Rent expense was \$4,378 for the year ended December 31, 2021.

The financial statements report certain categories of expenses that are attributable to multiple program or supporting activities. The Presbytery's primary expense category that is divided among program and supporting functions is Personnel (salaries and benefits), which is allocated among the Ministry & Mission, Ecclesiastical & Pastoral, and Management & General (including finance and administration) functions according to longstanding formulas. Kirkwood Camp's Personnel and other expenses are reported on a standalone basis.

The Presbytery's Direct Program Support is allocated primarily to Ministry & Mission, and incorporates operating budget support provided to Community Ministries, as well as to Kirkwood Camp (in addition to program expense incurred by Kirkwood itself), and the Seminary Partnership and Incubator programs. It excludes restricted fund grant activity, which is reflected under Support of Specified Causes.

Several of the Presbytery's other expense categories, including Equipment & Supplies, Maintenance, Insurance & Professional Fees, Depreciation, and Telephone & Utilities, are allocated primarily to the Finance & Administration function.

#### NOTE 10 COMMITMENTS AND CONTINGENCIES

#### **Guarantees**

Certain church properties and affiliates in which the Presbytery holds title, and others which are held in the name of corporations of individual congregations, are subject to mortgages, as approved by the Presbytery. Mortgages are owed to the Presbyterian Church (U.S.A.) and commercial lending institutions. Individual church congregations assume all such obligations and make required payments directly to the mortgagor. On occasion, as approved by the trustees, the Presbytery guarantees the mortgages of the member congregations. At December 31, 2021, the Presbytery guaranteed mortgages with various financial institutions with outstanding balances of approximately \$5,080,426.

#### Other

The Presbytery is engaged in legal actions arising in the ordinary course of its business. The Presbytery believes that the ultimate outcome of all such matters will not have a material effect on Presbytery's financial position.

#### **NOTE 11 LIQUIDITY**

The Presbytery had approximately \$605,100 of total cash and cash equivalents plus short-term investments as of December 31, 2021, of which \$57,650 represented funds held for others (primarily the General Assembly and Synod), leaving \$547,450 of total liquidity, or about five months of Presbytery operating expenses.

The Presbytery invests cash in excess of normal requirements (short-term investments) in shares of a money market fund which holds securities maturing in 397 days or less (with certain exceptions) and having a weighted average maturity of 60 days or less and a weighted average life of 120 days or less.

Total available investment income from sources with both donor restrictions and without donor restrictions (funds) used in the Presbytery's 2021 operating budget was approximately \$339,000, or an estimated three months of operating expenses. A portion of the Presbytery's investment income is comprised by a total return distribution from certain funds based on the average of their values as of the end of the three previous years, i.e., 2018 through 2020 (less actual income received from those funds in the prior year).

The balance of the Presbytery's operating budget is funded through annual contributions from churches, both in the form of per capita (also known as apportionment) payments, which are based on the number of members in each church, plus discretionary mission support by individual churches.

#### NOTE 12 RESTATEMENT

In 2021, the Presbytery's management completed a comprehensive review of net asset balances and restrictions as part of a financial system conversion. This review identified certain errors occurring over a number of prior years, resulting in an overstatement of net assets without donor restrictions and an understatement of net assets with donor restrictions previously reported as of December 31, 2020. The accompanying 2020 financial statements have been restated to correct these errors. The effect of the restatement was to decrease net assets without donor restrictions by \$528,929 and increase net assets with donor restrictions by the same amount.

Removes the current requirement that a minister of the Word and Sacrament lead the prayer of thanksgiving that concludes the Lord's Supper liturgy

Adds a sentence about "signs and symbols of blessing" to the section on ordination and installation services

#### 22-X W-5.0104 HOUSEHOLD WORSHIP (TWE-05 5)

#### 22-Y W-5.0104 HOUSEHOLD WORSHIP (TWE-05 6)

Adds an additional paragraph to the existing section on household worship

Adds "discipleship" to a list of the Church's ministries that are connected to its worship, and adds references to statements in the Foundations of Presbyterian Polity

### Report of the Administrative Commission to Glading Memorial Presbyterian Church

Members of the AC: Rev. Cynthia Betz-Bogoly, chair (Elkins Park), Rev. Randy Barge (Olney, First), Ruling Elder Susy Christiansen (Philadelphia, First), Ruling Elder Gina Baah (United Ghanian), Ruling Elder Steve Bauer (Flourtown).

- AC first met on April 28, 2022 with Presbytery Stated Clerk Rev. Kevin Porter, Elder Mike Henry (Valley Forge) Trustees, and Elder Jim Ballangee (Arch Street) Commission on Ministry to discuss the decision of the Glading Memorial Presbyterian Church to prepare for closure of their church.
- May 9, 2022 AC joined the Session of Glading for their meeting to discuss acceptance of the sale offer for their entire campus and all buildings from their current tenant Amazing Kidz.
- Rev. Betz-Bogoly met with Rev. Debbie Heffernan, Glading's pastor, on May 11, 2022 and took a tour of Glading's campus and to discuss next steps in the closure of the congregation and sale of the campus.
- AC met on Wednesday, May 11 after receiving the news that Trustees of the Presbytery of Philadelphia and the Collegium of the Presbytery approved the sale of the Glading Memorial Presbyterian Church to Amazing Kidz.
- The Glading congregation held a congregational meeting after worship on Sunday, May 15, 2022 to affirm the sale agreement. This was an in-person meeting at the church. Elders Baah and Bauer were present to attest to the unanimous vote from the congregation to approve the sale terms with *Amazing Kids*.
- June 12, 2022 Elder Christensen attended the Glading congregational picnic after worship. She offered a listening ear to the current members, former members who had returned for the picnic, and those from the Hungarian congregation who also worship in the Glading sanctuary.
- Rev. Betz-Bogoly stayed in contact with Rev. Heffernan and Elder Clara (Glading's Clerk of Session) over the summer offering support and resources for the church members seeking to find new church homes.
- August 5, 2022 there was a discussion with Elder Mike Henry, Rev. Debbie Heffernan, and Rev. Betz-Bogoly regarding the church treasurer's inquiry about funds from the previous sale of the manse as well as current expenses regarding investments and liquid assets.
- August 8, 2022 Rev. Heffernan called a Session Meeting to discuss the financial questions that had arisen and all misunderstandings were cleared up.
- September 13, 2022 Rev. Betz-Bogoly and Rev. Heffernan had a meeting about updates and progress.
- Rev. Betz-Bogoly shared updates with the AC members on September 29, 2022 regarding questions and answers between Glading's Session and Mr. Jim Wagner Director of Business Administration of the Presbytery of Philadelphia for how to handle funds, invoices, and loose

ends with the church finances after the January 8, 2023 closure of the church and dissolution of the congregation. The presbytery will consolidate all remaining financial assets to allow for Mr. Wagner to handle any invoices and other financial needs after January 8, 2023 through the presbytery's financial office.

- Rev. Betz-Bogly has invited Rev. Heffernan and members of the Glading Memorial congregation to be present at the November 15, 2022 meeting of the Presbytery of Philadelphia to celebrate Glading's ministry.
- Glading Memorial Presbyterian Church will hold a worship service in celebration of its ministry on the afternoon of January 8, 2023.

The Administrative Commission would like to thank the congregation of the Glading Memorial Presbyterian Church, Rev. Debbie Heffernan, and the Trustees of the Presbytery for their support, cooperation, and patience in this process. We ask God's blessing upon those who will continue to use the Glading campus into the future. We also encourage all the members of Glading to continue to worship with a new faith community as they serve our Lord into the future.
