Sisters and Brothers in Christ of the Presbytery of Philadelphia,

We recently concluded the Season of Christmastide with Epiphany. Epiphany is the day we remember the Magi as God revealed to them the Star in the East which led them to the Christ Child in Bethlehem. It was a rigorous twelve-day journey for the Magi but one in which their eyes were upward to the Star that led them to the Messiah. Eyes upward was what enabled them to be in the presence of Christ and to experience a life changing epiphany of Christ's love.

Epiphany happens at the beginning of year but it is also a time to see what epiphanies we might have had the previous year. As I look back on 2022, the Epiphany for me as Moderator of this Presbytery was community. Through moderating installation and ordination services and being present in gatherings throughout the year there was a sense of a new connectedness for me within this body of believers. Through new relationships, I now feel more connected to the Presbytery than I have ever felt before. I have established rapport with Presbytery leadership, pastors and congregants that have encouraged me to know that I am not alone but we are on this journey together as disciples of Jesus Christ proclaiming the gospel to all people. We are connected in this calling through our love of Christ. A love to receive and a love to share. Thank you for the ways that you care of one another in this presbytery.

Love is shared with words but also with deeds, as I reminded of the story of a little boy named Jimmy who was only five years old. He came home from school one day and decided to play outside in the backyard. His mother was watching him as she always did through the kitchen window. As she was watching him she noticed that he left the yard but she wasn't concerned as he went to the next door neighbor's house. He walked up the front steps of the house and then she noticed that he climbed into the lap of Mr. Thompson who had his hands over his face and seemed to be sobbing as just a few days prior his wife had died. She noticed then Jimmy rocking back and forth with Mr. Thompson on his rocking chair for about 20 minutes and then he came home for dinner. Jimmy's mother then asked, "What did you say to Mr. Thompson and Jimmy replied, "Nothing, just helped him cry."

The story of Jimmy reminds me that some of our most important moments of sharing God's love are just being there for those who are hurting and suffering. Sometimes nothing needs to

be said as it is the action of being there that matters most, as the first thing Jesus did at the home of Mary and Martha was to weep with them when they were mourning the loss of their brother Lazarus.

I believe as a Presbytery sharing God's Love is at the heart of who we are. We have been called by God to love each other within the Presbytery and to love those outside of our Presbytery. I have great hope of the love of Christ flowing from us in this New Year. A year in which God has an Epiphany of love for us and a year in which we will be Epiphany moments of God's love to others. Moments in which we will reach out to those close to us and moments in which we will reach out to those who are all alone.

As I close, my encouragement is to have our eyes upward and if we do, we will not miss God's love of us and the divine calling to love others in 2023.



Rev. Dr. Jonathan Lee Walton President, Princeton Theological Seminary



Dr. Walton comes to Princeton Seminary from Wake Forest University's School of Divinity in Winston-Salem, North Carolina, where he has served as the dean since 2019 and holds the Presidential Chair in Religion and Society. Prior to joining Wake Forest University, he served on the faculty at Harvard Divinity School and was the Plummer Professor of Christian Morals and the Pusey Minister in the Memorial Church of Harvard University.

"Theological education is at an inflection point," says Dr. Walton. "The church is changing. Society is changing. So we need clear-minded, faith-informed profes-

sionals who can speak hope, equity, and healing in all fields of human endeavor."

Dr. Walton is trained as a social ethicist whose scholarship focuses on the intersection of evangelical Christianity, mass media, and political culture. He is the author of two books: *Watch This! The Ethics and Aesthetics of Black Televangelism* (NYU Press, 2009) and *A Lens of Love: Reading the Bible in Its World for Our World* (Westminster John Knox Press, 2018). He has published widely across various academic journals, books, magazines, and newspapers. His insights have been featured in the New York Times, CNN, Time Magazine, and PBS.

Dr. Walton earned his PhD in 2006 and his MDiv in 2002 from Princeton Seminary, and his bachelor's degree in political science from Morehouse College in 1996. He is an ordained Baptist minister and a gifted preacher who has continued to serve both his alma maters. He is a member of the Humanities Advancement Council at Morehouse College and has served on the Board of Trustees at Princeton Seminary.

Elder Zandra Maffett has been a member of Valley Forge Presbyterian Church, King of Prussia, PA, since 1978. In that time she has served as a member of the Long -Term Vision Committee, as well as Chair of the Mission Committee. In addition to serving as a Sunday School teacher, she has participated on church mission trips to Presbyterian Disaster Assistance host sites in Pearlington, MS and Towanda, PA. Elder Jim Ballengee, Vice-Moderator of the Presbytery of Philadelphia



Elder Jim Ballengee grew up as a member of Ardmore Presbyterian Church and joined Arch Street Presbyterian Church in the first class of Elders in 2009 as the church began to revitalize. He has served on Session for 8 years at Arch Street Presbyterian Church in addition to roles on Personnel, Nominating, and Mission and Outreach. He is completing his sixth year on the Presbytery's Commission on Ministry – the last 2 ½ years as Moderator of the group.

REDRESS OF IMBALANCE

The *Book of Order* (G-3.0301) requires the Presbytery to "adopt and communicate to the sessions a plan for determining how many ruling elders each session should elect as commissioners to Presbytery."

An examination of the total number of members of the congregations of the Presbytery and the total number of minister members reveals a ratio of 76 congregants for every minister member. Using each congregation's reported 2021 membership and assigning 1 ruling elder commissioner for every 76 members would lead to the following number of ruling elder commissioners for each Presbytery meeting. (Please note: This allocation caps the maximum number of ruling elder commissioners for all congregations of 2,000 or more at 20.)

Total Minister Members: 316 ♦ Total Congregation Membership: 24,154

Committee on Bills & Overtures Report B-1

Action Item: The Committee on Bills and Overtures recommends the Presbytery of Philadelphia approves the proposed amendments listed in Appendix A (see below). *All Proposed amendments in Appendix A are being presented as on motion in the *PROPOSED AMENDMENTS CONSENT AGENDA.

The 225th General Assembly (GA225) of the Presbyterian Church (U.S.A.) approved and recommended to the presbyteries, for their affirmative or negative votes, proposed changes to the language of the Book of Order that, if approved, will amend the Constitution of our denomination.

Our Bills and Overtures Committee, consisting of our commissioners to GA225 has reviewed the proposed amendments, which can be viewed by downloading the Proposed Amendments to the Constitution booklet (by clicking https://presbyphl.org/wp-content/uploads/sites/22/2022/12/B-Bills-and-Overtures.pdf) or via the link to our Stated Meeting (https://presbyphl.org/event/jan-31-2023-stated-meeting/). Bills and Overtures has proposed the following process for the Presbytery of Philadelphia's consideration:

Step 1: January 31st Stated Meeting

The vast majority of the proposed amendments will be presented as a *PROPOSED AMENDMENT CONSENT AGENDA (see **Appendix A** below) to be considered at the January 31 stated meeting of the Presbytery. Most of these proposed amendments fall broadly within three categories:

- Proposing language that updates/expands existing language or changes grammar
- Proposing language that provides guidance or reflects existing standard practices
- Proposing language that is more permissive than existing language.

As always, any commissioner may remove any of the items from the consent agenda for any reason at any time prior to it being considered for approval. Only commissioners present inperson at the meeting will have the opportunity to do this as we will not be able to accommodate virtual voting at this meeting.

If an item is pulled from the consent agenda, it will be considered at the April 25th stated meeting. All remaining items on the consent agenda will be considered together at the January 31st meeting with the one action on the Bills and Overtures recommendation that the Presbytery approve them.

Step 2: April 25th Stated Meeting

The remaining proposed amendments, consisting of the items Bills and Overtures has already identified as warranting further discussion (see Appendix B below) as well as those pulled from the January 31st consent agenda will be presented to the Presbytery for consideration at our April 25th stated meeting.

22-F (pg. 13)	G-20505a(1) TRANSFER OF MINISTERS OF OTHER DENOMINATIONS (POL-15) Adds the requirement to consult with other denominations when receiving immigrant pastors without otherwise acceptable PC(USA) ordination education requirements Rationale: This small amendment offers helpful prescriptive guidance and permissive language (such as the presbytery should provide such educational opportunities) to the current BoO.
22-M (pg. 29)	G-3.0104 OFFICERS (MC-05) Adds language that "it is appropriate" to adopt procedures for electronic session meetings Rationale: Similar to 22-C, this amendment updates the language to our BoO to reflect current standard practice.
22-N (pg. 31)	G-3.0105 MEETINGS (ROD-06 3) Adds provision that all councils and their commissions and committees may meet electronically Rationale: Similar to 22-C, this amendment updates the language to our BoO to reflect current standard practice.
22-O (pg. 33)	G-3.0106 ADMINISTRATION OF MISSION (HSB-05 9) Adds language regarding boundary training, including sexual abuse to the requirement for sexual misconduct policies required of councils Rationale: This proposed amendment originated as a recommendation from the GA Health Safety and Benefits Committee as Recommendation 9 attached to the Survivors of Sexual Misconduct Task Force recommendations. This amendment updates the language and guidance to our BoO to reflect current standard practice.

22-E (pg. 60)	D-10.0303 PETITION FOR REVIEW (ROD-04 1) Amends the current Rules of Discipline to include notifying the person accused if no charges will be filed (instead of just the person(s) who made the accusation).

Receiving a disciplinary decision against a member of the congregation as required by D-9.0102."
22-E (pg. 11)	G-2.0503 CATEGORIES OF MEMBERSHIP (POL-07) Removes "honorably" before "retired" as the category for retired ministers Rationale: The current BoO only designation of retirement for ministers is "Honorably Retired." That designation may be perfectly fitting for many Presbtyerian ministers as they retired from active pastoral roles, but presbyteries sometimes face situations in which a minister's service has been marked by difficulties and challenges that do not rise to the level of formal disciplinary charges and censure, but which are hardly worthy of the label "Honorable." 22-V (pg. 44)	W-3.0414 COMMUNION (TWE-05 4) Removes the current requirement that a minister of the Word and Sacrament lead the prayer of thanksgiving that concludes the Lord's Supper liturgy.

	Rationale: This permissive amendment provides for more flexibility in the prayer after communion, including the use of a unison congregational prayer.



TULLY MEMORIAL PRESBYTERIAN CHURCH ADMINISTRATIVE COMMISSION REPORT TO THE PRESBYTERY OF PHILADELPHIA JANUARY 31, 2023 STATED MEETING

BACKGROUND

The Leadership Collegium of the Presbytery appointed the Administrative (AC) on July 27, 2022, in response to a letter received from the session of Tully Memorial Presbyterian Church requesting guidelines and assistance for dissolution of their congregation.

<u>Summary</u>

The AC held its first meeting on September 2, 2022, via Zoom. In attendance were the AC, Pastor Komlan Ezunkpe, Paula Dixon, Clerk of Session and Lynwood Dixon, President of the Corporation.

Pastor Ezunkpe, reported that in July the congregation had met and voted to accept the session's recommendation to dissolve. The congregation hoped that their last service would be December 2022. There had been a Care Team in place but the financial situation had not improved. The Tully congregation held on for as long as they could to be a witness in Sharon Hill for the Ewe community. During this initial meeting, suggestions were put forth by members of the AC as to where the members could worship. Being a geographically dispersed congregation, the congregational leadership felt it would be difficult to find one congregation that would meet the needs of the members.

Assuming all legal and financial obligations were completed a celebration of the congregation's ministry and witness could take place at the November or the January 2023 Presbytery meeting.

Paula Dixon agreed to collect the necessary paperwork outlined in the dissolution of a church document. The records of the church will be given to The Historical Society. Lynwood Dixon agreed to meet with the financial staff at the Presbytery to deliver all financial records. This would include bank statements, outstanding bills, leases, agreements, contracts, and

endowments. An update was needed on the status of the mortgage and loan documents from the sale of the real property in 2018. At that time Tully granted a mortgage to the buyer as part of the sale agreement. A list of all personal property was also requested.

The next meeting of the AC was held by Zoom was October 11, 2022 at which time it was determined all mortgage and lease agreements have been given to the Presbytery for review. The AC agreed that Tully receive the mortgage payments until the end of the year, providing monies to pay most of the outstanding bills and partial payroll.

The October 25, 2022 AC meeting was held by Zoom. The last worship service for Tully was held on November 13, 2022 @11:00. The building can be in use until the end of the year.

December 6, 2022 AC meeting held by zoom. All financial records have been delivered and Paula Dixon is working with the Historical Society for the records to be archived.

On December 23, 2022, the Leadership Collegium approved modifying the charge of the AC to more explicitly grant the AC original jurisdiction.

Final Meeting January 6, 2023. Having been granted "original jurisdiction" legal papers granting the Presbytery of Philadelphia power of attorney were signed by Moderator, Julia Hill.

There are still a few remaining bills needing to be paid along with mortgage receipts from the buyer. The mortgage is in the process of being assigned from Tully to the Presbytery. At that time mortgage payments by the buyer will be sent directly to the Presbytery.

In recognition that circumstances beyond our knowledge or control may continue to influence decisions regarding both the disposition of the property, on behalf of the AC, I move the following:

MOTIONS:

- 1) That the presbytery affirms the faithful witness of the Tully Memorial Presbyterian Church with gratitude for its over 114 years of faithful witness and service to Christ and approves the dissolution of the Tully Memorial congregation and authorizes the appropriate entities of the Presbytery to resolve any outstanding matters related to the congregation.
- 2) That the Administrative Commission be dismissed with thanks.

TRINITY PRESBYTERIAN CHURCH IN KENSINGTON ADMINISTRATIVE COMMISSION REPORT TO THE PRESBYTERY OF PHILADELPHIA JANUARY 31, 2023 STATED MEETING

BACKGROUND

The Leadership Collegium of the Presbytery appointed the Administrative Commission (AC) on August 2, 2021 to respond to the request of the session of the Trinity Presbyterian Church in Kensington for dissolution of the congregation. Our charge was to be in conversation with the session for the purpose of gaining information regarding the viability of their ministry and facilities, and to make recommendations to the Presbytery regarding any actions to be taken.

Rev. Laura Colee (Beacon) agreed to serve as Moderator and serving as members:

Rev. Adan Mairena (West Kensington Ministry) Elder Julia Hill (Yeadon) Elder Frank Orzehoski (Warminster, First) Rev. Randy Barge (Olney, First)

SUMMARY

Prior to the appointment of the Trinity AC, a Care Team composed of Rev. Adan Mairena, Rev. Laura Colee, Elder Julia Hill, and Elder Frank Orzehoski was created in order to walk alongside the Trinity congregation as they navigated ending their housing ministry and determined how to best care for their property. Rev. Colee agreed to serve as the Moderator of the Care Team and Rev. Mairena agreed to serve as the Moderator of Trinity's session. The Care Team had its first introductory meeting over Zoom on June 24, 2021. Representatives from the Care Team took a tour of the Trinity property on July 7, 2021.

On August 2, 2021, those on the Trinity Care team were appointed to the Administrative Commission of Trinity, with the addition of Rev. Randy Barge. Over the next several months, the AC, along with additional representatives from the trustees and legal counsel of the Presbytery of Philadelphia, supported Trinity in:

- o ending their residential recovery housing ministry,
- o securing their facility,
- o corresponding with their insurance company,
- o and navigating legal challenges related to a former housing ministry resident.

On December 6, 2021, the AC received notice that the legal issues with the former Trinity resident had been resolved. Since the creation of the Care Team in June 2021 and the AC in August 2022, the Trinity congregation continued to hold regular Sunday worship services.

On October 3, 2022 at a congregational meeting duly called and moderated by the Rev. Mairena and witnessed by Rev. Kevin Porter, the congregation voted to request the Presbytery of Philadelphia to concur with the request for the Trinity congregation to be dissolved at an upcoming Stated Meeting of the Presbytery. The congregation also voted to hold a final service and celebration of witness and

ministry on October 30, 2022. At this closing worship service, the former Trinity Pastor Rev. Tom Wray led worship and Rev. Ashley Rossi attended as a representative from the Presbytery.

At the end of December 2022, a motion was submitted to the collegium of the Presbytery of Philadelphia to amend the AC's charge to include the statement, "the AC is granted original jurisdiction." This amended language allowed for the expedited sale of the property at Trinity. On January 10, 2023, Rev. Colee, as the AC Moderator, signed a Power of Attorney agreement to assist in the sale of the Trinity property.

From October through January 2023, the AC continued to work with the Trinity congregation to complete the tasks required for dissolution.

In recognition that circumstances beyond any of our knowledge or control may influence decisions regarding both the disposition of the building, and on behalf of the AC, I move the following:

MOTIONS:

- 1) That the presbytery affirms the faithful witness of the Trinity Presbyterian Church in Kensington with gratitude for its over a century-long witness and approves the dissolution of the congregation and authorizes the appropriate entities of the Presbytery to resolve any outstanding contractual matters related to the congregation.
- 2) Upon completion of today's vote, the AC is dismissed with thanks.
