The Presbytery of Philadelphia held its Stated Meeting at the First Presbyterian Church of Springfield (Flourtown) in Flourtown, Pennsylvania on Tuesday, November 15, 2022 at 1:05 P.M.

Prior to the meeting, the Presbytery took part in a Pre-Presbytery conversation of visioning and hope for our smaller congregations.

The Presbytery was called to order at 1:05 P.M and convened with prayer by the Moderator, Reverend Ted Mingle (Lower Providence). Moderator Mingle began the business portion of the meeting by calling upon the Rev. Diane Jamison Fitch (Flourtown) to give the arrangements and welcome the body.

Moderator Mingle then called upon the Stated Clerk, Rev. Kevin Porter (Presbytery of Philadelphia, Stated Clerk) for his report.

From the **Stated Clerk** (Attachments A & S) Reverend Porter submitted the following:

- Introduced the **Docket** for approval. The **docket was approved by the body as presented.**
- Introduced the Consent Agenda (Attachment A) for approval. The Presbytery approved the consent agenda as amended to include the names of the following Ruling Elders in the necrology report.

 - o Rev. Porter also reminded the body to send any names of elders or minister members who had passed in 2022 to the Presbytery Office for inclusion in our 2022 necrology report.
- Introduced 1 Corresponding Member: Rev. Larissa Kwong Abazia (Coastlands Presbytery) Upon motion and proper second **the Presbytery voted to seat them as a Corresponding Member.**

Moderator Mingle subsequently called for upon our new Minister members Rev. Cassie Heintz, Rev. Ishfaq Sahotra, Rev. Andy Jacob, and Rev. Cean James as well as any first time Elder Commissioners, who were encouraged to message the office of the Stated Clerk to insure they are appropriately welcomed.

- Elders Linda Phelps (Flourtown), Meggin Capers (Bryn Mawr), Leslie Donaghy (Carmel), Tricia Robinson (Flourtown), Herbert Brahbam (Overbrook), Mary Jane Gore (Crossroads), Larry Hambrecht (Oxford), and Dottie Bouer (Bryn Mawr) were welcomed.
 - o The Stated Clerk also lifted up the online statistical reporting for the Year End Reports

- will be available for our clerks December 2, 2022 through February 16, 2023. Rev. Porter also lifted up last years' reports are available on page S-4.
- Beginning on page S-10 is the list of proposed amendments to the Book of Order coming down to the Presbytery's for ratification from the 225th General Assembly which the Bills and Overtures Committee will be making recommendations in the new year.
- At this point Reverend Porter called upon Reverend Cynthia Betz-Bogoly (Elkins Park), chair of the Administrative Commission for the Glading Memorial Presbyterian Church to bring her report.

From the Administrative Commission for the **Glading Memorial Presbyterian Church** (Attachment S)

Rev. Betz-Bogoly lifted up the history of the church, as well as the work of the Administrative Commission. At this point, Glading Memorial's current pastor, Rev. Debbie Heffernan (Glading) and Member Elder Jim Wood spoke about the church and the 88 year ministry of the church.

At the conclusion of her report and upon motion duly seconded the Presbytery voted to in the affirmative of the following motions:

- 1) That the presbytery affirms the faithful witness of the Glading Memorial congregation with gratitude for its over 88 years of faithful witness and service to Christ and approves the dissolution of the Glading Memorial congregation and authorizes the appropriate entities of the Presbytery to resolve any outstanding matters related to the congregation.
- 2) Upon completion the January 8, 2023 closing memorial service the AC be dismissed with thanks.

At the conclusion of the vote, the members of Glading Memorial Presbyterian Church and their AC were invited forward and Reverend Betz-Bogoly prayed over the ministry and saints of the Glading Memorial Presbyterian Church.

At this point Moderator Mingle called upon Elder Jim Ballengee (Arch Street) and Rev. Joyce Shin (Swarthmore) forward to give the Commission on Ministry and Commission on Preparation for Ministry and Membership Report.

From the **Commission on Ministry** and **Commission on Preparation for Ministry and Membership** (Attachments C & P)

Elder Ballengee outlined the role of the COM and gave information regarding the approved call of **M. Courtenay Willcox** to serve as Transitional Pastor of the Tree of Life Presbyterian Church.

Rev. Shin then shared the call and work the CPMM does on behalf of the Presbytery with our candidates, inquirers. She then called upon Mrs. Willcox who shared with the assembly a brief history of her background followed by the reading of her Statement of Faith. Following a time of questions and responses, a motion to arrest the examination was received, duly seconded and approved. Mrs. Willcox was then excused from the meeting and the Presbytery, having received a motion to sustain the examination of M. Courtenay Willcox for ordination, voted in the affirmative. Mrs. Willcox returned to the meeting and Rev. Dr. Agnes Norfleet (Bryn Mawr) and the saints of the congregations in her life prayed over the candidate.

At this point Moderator Mingle invited Elder Zandra Maffett (Valley Forge) to shepherd the presbytery through the next portion of the docket.

Vice-Moderator Mingle called upon Elder Bob Kenworthy (Wallingford) to bring the report of the Committee on Nominations.

From the **Committee on Nominations** (Attachment N)

Elder Kenworthy began his report by lifting up all the members of the Presbytery who served on various Commissions and Committees to rise and be acknowledged, especially lifting up those whose terms are coming to an end in December.

Following the moment of gratitude Elder Kenworthy presented the names to serve on the standing commissions and committees of the Presbytery. Vice Moderator Maffett then called for any nominations from the floor; seeing none, a motion for the nominations for standing commissions and committees was duly seconded, received, and approved with the addition of the names of Elder Linda Rutkosky (Doylestown) to serve on the Commission on Preparation for Ministry and Membership (Class of 2025) and Ms. Erica Zaveloff (Non-Presbyterian) to serve on the Committee of Self-Development of People (Class of 2025).

Elder Kenworthy then presented Elder Zandra Maffett (Valley Forge) and Elder Jim Ballengee (Arch Street) as the names for the Moderator and Vice-Moderator of the Presbytery for 2023 respectively. Seeing no nominations from the floor, a motion for the nominations for Moderator and Vice Moderator of the Presbytery for 2022 was duly seconded, received, and approved.

From the **Leadership Collegium** (Attachment L)

At the conclusion of his report, Vice Moderator Maffett called upon Moderator Mingle to share the Leadership Collegium Report. He highlighted the following:

- Reverend Mingle lifted up the ordination of the Reverend Cassie Heintz at the Oxford Presbyterian Church.
- Reverend Mingle also lifted up upcoming conversations with our Jewish colleagues in ministry on November 16 and December 14.
- Rev. Carla Jones Brown (Arch Street) and Rev. Dr. John Willingham (Doylestown) were called upon bring the report of the Committee on Personnel.
 - Reverends Jones Brown and Willingham lifted up Reverend Kevin Porter's many years of service to the Presbytery and made the following motion: to re-elect Reverend Kevin Porter to the Office of Stated Clerk of the Presbytery of Philadelphia for a 5-year term. This motion was received, duly seconded, and unanimously approved.

Following the motion, Reverend Carla Jones Brown prayed of Reverend Porter, giving thanks for his ministry among us.

At the conclusion of the report, Vice-Moderator Maffett lifted up what a blessing her recent trip to Louisville for the Moderators Conference was.

At this point, Vice-Moderator Maffett returned the duties of shepherding the meeting to Moderator Mingle.

Moderator Mingle then called upon the Reverend Ruth Faith Santana-Grace (Presbytery of Philadelphia, Executive Presbyter) for her report.

From the **Executive Presbyter**

During her report, Reverend Santana-Grace invited **Reverends Larissa Kwong Abazia** (Presbytery of the Coastlands) and **Brenton Thompson** (Presbytery of Philadelphia) to bring a report on the Vital Congregations Initiative.

- During their report Reverends Abazia and Thompson lifted up the congregations that participated in the Presbytery's two year journey with this program. Giving thanks for their willingness to participate and vision together. The congregations were gifted with a painting to remember their time in this program.
